Registration opens May 1 for Northborough Rec's summer T-Ball League. We are in need of 2 adult coaches per team for approximately 12 teams, with a max of 12 kids per team. Previous coaching experience is not required, training will be provided. Coach with a spouse, neighbor, friend or relative, or we can pair you with someone. Applicants must successfully pass CORI background screening. You do not have to be a Northborough resident to coach or play.

This program will run Tuesday evenings at Ellsworth-McAfee Park, Northborough. Coaches are asked to arrive at 6pm to help set up and stay until 7:45pm to break down. This is a 6 week long program running July 9-August 13; we have staff that can provide alternative coverage if you have vacation plans.

This program is for children ages 4-6 years old (must be 4 by the start of the program). If selected as a coach, your child will be placed on your team in advance of May registration.

Submission of this application does not guarantee your status as a coach. Staff will follow up to confirm. 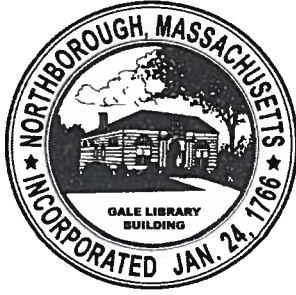

TO BE USED BY ORGANIZATIONS CONDUCTING CORI CHECKS FOR EMPLOYMENT, VOLUNTEER, SUBCONTRACTOR, LICENSING AND HOUSING PURPOSES.
